

## Local Authority Youth Services Survey Context

The survey was submitted to 154 local authorities and we received responses from 98 (60%). Limited information is held by Central Government. The survey was undertaken to develop a broader understanding from frontline staff of how local authorities are meeting their statutory duty by securing services and activities for young people to improve their wellbeing [statutory duty below].

### Education and Inspections Act 2006

507B LEAs in England: functions in respect of leisure-time activities etc for persons aged 13 to 19 and certain persons aged 20 to 24

*(1) A local education authority in England must, so far as reasonably practicable, secure for qualifying young persons in the authority's area access to—*

*(a) sufficient educational leisure-time activities which are for the improvement of their well-being, and sufficient facilities for such activities; and*

*(b) sufficient recreational leisure-time activities which are for the improvement of their well-being, and sufficient facilities for such activities.*

The survey was sent to individuals within the local authority primarily responsible for young people's services. We discerned no noticeable pattern amongst youth services teams that did not respond. The survey consisted of 39 questions. Most were closed questions that were analysed using quantitative methods. Respondents were told that their individual responses would not be released publically.

There are certain caveats to this data which should be considered, these are summarised below.

#### *Response rate*

- Youth services teams from 56 local authorities did not complete the survey, therefore we do not have information on the how services are secured in these areas.

#### *Incomplete data*

- There were some questions that were not answered and/or were not fully completed by all local authorities. Preliminary work was undertaken to verify some of the information submitted, however this was not exhaustive.

#### *Accounting and categorisation*

- We recognise that local authorities define youth services in different ways, and although definition guidance was provided it can be difficult to make direct comparisons between local authorities and over time as these definitions differ at a local, and national, level.

#### *Uncertainty about the future*

- Several questions referred to future predictions around service delivery. We recognise that in a fast-changing landscape some of these predictions will have been made under conditions of uncertainty.
